### ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH THIS EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently prepared or trained for participation in this activity, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this activity.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity in which I may participate, and that it will govern my actions and responsibilities at said activity.

In consideration of my application and permitting me to participate in this activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this activity, THE FOLLOWING ENTITIES OR PERSONS: Warriors and Rodeo, (WAR) and/or their directors, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers;

(B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise. hereby acknowledged, do hereby release and forever discharge [Warriors and Rodeo], their agents, employees, successors and assigns, and their respective heirs, personal representatives, affiliates, successors and assigns, and any and all persons, firms or corporations liable or who might be claimed to be liable, whether or not herein named, none of whom admit any liability to the undersigned, but all expressly denying liability, from any and all claims, demands, damages, actions, causes of action or suits of any kind or nature whatsoever, which I now have or may hereafter have, arising out of or in any way relating to any and all injuries and damages of any and every kind, to both person and property, and also any and all injuries and damages that may develop in the future, as a result of or in any way relating to the following:

I acknowledge that WAR and their directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

I acknowledge that this activity may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, monitors, and/or producers of the activity. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.

I understand while participating in this activity, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Warriors and Rodeo, or the employees, representatives or agents of Warriors and Rodeo and event facilities.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

\_\_\_\_\_ Name of Minor Child /Legal Dependent Assumption of Risk As the parent or guardian of the below named minor or dependent, I assume full responsibility for the decision for my child/legal dependent to participate in events with Warriors and Rodeo. I acknowledge that participation by my dependent in the activities listed above may entail known and unanticipated risks, which could result in physical injury, death or property damage. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activity. These risks may also occur as a result of my dependent's own actions, inactions or negligence, as well as actions, inactions or negligence of others, weather conditions, condition of equipment, condition of the facilities and grounds, natural disaster, national disaster, and any first aid emergency treatment which may be administered. There may also be other risks that are not foreseeable at this time. Release As part of the consideration for my dependent participating in the activities identified above, I release, discharge, and hold harmless Warriors and Rodeo, its owner, any director, officer, employee, or any person acting in any capacity on their behalf (hereinafter collectively referred to as "WAR") from all demands, causes of action, suits, contracts, agreements, obligations, covenants, defenses, costs, liabilities and judgments, whatsoever, known or unknown, suspected or unsuspected, in contract or in tort, in law or in equity, which I might have against WAR, arising from my child/dependent's participation in the Programs. Waiver and Indemnification I hereby waive all claims and demands against WAR for any loss, damage, injury (including death) or claim of any kind arising from, related to or caused by my dependent's participation in Warriors and Rodeo Events and

agree to indemnify, defend, and hold harmless WAR from all loss, liability, damages, costs, and expenses (including actual attorney's fees) arising from or related to same. Photography/Video In permitting my dependent to participate, I understand that my dependent's photograph/video may appear in publications or brochures marketing WAR programs and facilities. I understand that there are no rights granted to me or my dependents to inspect or approve photographs/video prior to publication. Term I have read this Agreement and agree to be bound by its terms. This Agreement shall be effective for all Warriors and Rodeo activities in which my dependent participates for a period of no less than one year from the date signed. By signing this agreement, I understand that my child can participate in these events in my absence, unless specifically noted in writing and excluded by parent/legal guardian on this waiver.
